

ARTICLE 3. Shall the voters of Fair Haven vote to elect officers for the following terms: Moderator for one (1) year; First Constable for two (2) years; two (2) Selectmen for one (1) year; one (1) Selectman for three (3) years; Town Clerk for three (3) years; one (1) Lister for three (3) years; one (1) Lister for two (2) years of a three (3) year term; one (1) Trustee of Public Funds for three (3) years; one (1) Town Auditor for three (3) years; one (1) Town Auditor for two (2) years of a three (3) year term; one (1) Town Auditor for one (1) year of a three (3) year term; Grand Juror for one (1) year; Town Agent for one (1) year; one (1) Library Trustee for three (3) years; and one (1) Library Trustee for one (1) year?
