Fair Haven Planning Commission

Town of Fair Haven - November 1, 2023 - Regular Meeting

Agenda

1. Call to Order: Chairman Richards called the meeting to order at 7:00 pm.

2. New Business:

a. Revised Fair Haven Zoning Regulations presented to the Fair Haven Select Board. Chairman Richards explained that he and Mrs. Pritchard presented the updated Zoning Regulations with the mandatory regulations to the Select Board on Tuesday October 31, 2023. Mr. Richards explained that the Select Board is now looking them over and will hold a public hearing. They are hoping to adopt the regulations on December 12th and hold the public hearing at a date afterwards.

ZA Adams stated there was a portion of the updated zoning regulations that were supposed to be submitted to the State Commission of Commerce but this submission deadline was unintentionally overlooked. ZA Adams is getting assistance on how to handle the situation.

b. Neil Robinson - Requested discussion of the Fair Haven Town Plan update (15 minutes)

Mr. Robinson spoke to the Planning Commission about the importance of using the dam Fair Haven owns to generate hydroelectric power. He quoted from the book Shorting the Grid: The hidden fragility of our electric grid by Meredith Angwin (https://www.meredithangwin.com/books/) to help support his argument. Fair Haven is one of only two Vermont municipalities that owns their own dam. He believes that Fair Haven could make money by producing hydroelectric power and selling it back to the grid. There have already been studies conducted and presented to the town on how to implement hydroelectric productivity.

Mrs. Brown asked how his presentation pertains to the Town Plan. Mr. Robinson stated that hydroelectric power is included in the plan. Mrs. Brown asked Mr. Robinson to look at the goals in the Town Plan and tell the Planning Commission what you'd like their help with. Mr. Robinson stated that there is a meeting on November 14th in Rutland with the Agency of Natural Resources with the focus of getting green energy into our area. Fair Haven has a lot going for it and he'd like to see some group in the town government push for hydroelectric energy production. Chair Richards explained that the PC is very interested in having Mr. Robinson's input and expertise when they are working on the hydroelectric goal on page 21. Mr. Robinson asked what the obstacles were with the town in implementing hydroelectric production. Chair Richards explained that cost was a factor and that it would need to be brought to the

selectboard. Mr. Coupal asked how far the concept had gone in the past. Chair Richards explained that it had been taken to a feasibility study. Mr. Robinson explained that Green Mountain Power has changed their approach to renewable energy production since the last study.

Mr. Robinson left the meeting at 7:29 pm with the plan to help create the hydroelectric section of the Town Plan's goals.

c. Continue work on the Fair Haven Town Plan update.

The Planning Commission stopped at page 16 of the Town Plan at the last meeting. The update started with Mrs. Brown passing out a handout where she had collected a list of Fair Haven's Civic Organizations, Volunteer organizations and Clubs, and Historic Sites. It was noted that the Eagles club was left off the list and that the Eureka Lodge was written down twice. Mrs. Brown also handed out a history section collected by a historian that she would like the PC to look over.

Chairman Richards explained that Water and Sewer are on their section and will have something for the PC soon. Mrs. Sienkiewicz stated that she is ready to start the editing process as soon as they are able to allow her to begin. She also stated that gathering demographic and population information was easy, but she ran into trouble when looking for information on housing and renters and was having difficulty finding the other statistics that were asked of her to obtain. It was suggested that she contact Mr. Solomon to ask for assistance as he offered when he was in attendance. Mr. Coupal informed that the State is now having a few issues with the interpretation of Vermont's pre-colonial culture, he suggested that maybe the document "The Historical Architecture of Rutland County - Fair Haven" may have a biased interpretation of the cultural history of the town. He suggested that the PC listen to the podcast from Brave Little State about native cultures in Vermont titled "Recognised" (https://www.vermontpublic.org/podcast/brave-little-state/2023-10-19/vermont-recognized-tribes-canada-abenaki-first-nations-odanak-wolinak)

o Mrs. Pritchard asked if the water people are also doing an air quality section, as Mr. Solomon stated it needed to be included in the final version. The September 20th addendum asked the PC to add something along the lines of "Fair Haven's tree canopy is a valuable asset, providing shade, helping filter out air pollution particles, and sequestering carbon."

- Mrs. Brown stated that the parks section had been added in with the history section. She asked if the Recreation department was too new to be charged with the section's write-up. Chair Richards stated he would ask for their input on what is already there.
